Jack has written policies and procedures that have been adopted by over 1,000 law enforcement and corrections agencies across the U.S.

He was also Deputy Police Commissioner for the Baltimore Police Department and most recently the Chief of Investigations for the San Francisco District Attorney’s Office. Jerry is currently working as an investigator with the San Luis Obispo County Sheriff’s Office.

Jeff Carter retired December 2018 as the Deputy Director of the Fayette County Detention Center in Lexington, Kentucky. Jeff was an instructor for 5 years inside the academy where he trained over 700 recruits, molding them into successful leaders in the Corrections field. He presents jail training throughout the country and serves as an Expert Witness around the United States focusing on jail litigation.

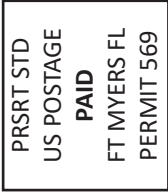
